INTRACO joint venture incorporates crane rental company in Myanmar

- ***Tat Hong Intraco Heavy Equipment Co Ltd will tap on opportunities created by Myanmar's increasing infrastructure needs***

SINGAPORE – 27 February 2014 – SGX Mainboard-listed leading trading company, **INTRACO Limited** (“**INTRACO**”, or together with its subsidiaries the “**Group**”), today announced the incorporation of Tat Hong Intraco Heavy Equipment Co Ltd (“**Tat Hong Intraco Myanmar**”) to undertake the business of rental of cranes and other related business activities in Myanmar.

Tat Hong Intraco Myanmar was incorporated by Tat Hong Intraco Pte Ltd, a joint venture company established on 28 August 2013 between INTRACO, SGX-listed crane company Tat Hong Holdings Ltd and prominent Myanmar businessman, Mr Aung Moe Kyaw. It will have a paid-up capital of US\$150,000 comprising 150,000 shares.

INTRACO Managing Director & CEO, Mr Foo Der Rong, said: “We are very excited to venture into the crane rental and distribution business in Myanmar together with established partners Tat Hong and Mr Aung Moe Kyaw. We believe the prospects for Tat Hong Intraco Heavy Equipment Co Ltd are promising as Myanmar is opening up and the country has many infrastructural needs with huge growth potential.”

The transaction is funded through internal resources and is not expected to have any material impact on earnings per share or net tangible assets per share of the Group for the financial year ending 31 December 2014.
