Intraco Limited (the "Company") announced on 22 June 2023 that the Company has launched a S\$50 million multicurrency, unsecured and unsubordinated commercial paper facility programme (the "SDAX CP Facility Programme") on a recognised licenced digital platform in Singapore operated by SDAX Exchange Pte. Ltd.

In connection with the above, the IL_D023_1A/SGD and IL_D016_1/USD, which was launched on 30 Sep 2025, under the SDAX CP Facility Programme, had matured on 30 Oct 2025.

Accordingly, the 218 Tokens (direct and deemed interest) in respect of the IL_D023_1A/SGD and IL_D016_1/USD issued on 30 Sep 2025 have been fully redeemed by the Company on 30 Oct 2025.
