The Board of Directors (the “**Board**”) of Intraco Limited (the “**Company**” or together with its subsidiaries, the “**Group**”) is pleased to announce the appointment of Mr Mak Lye Mun and Mr Hoon Chee Wai as Independent Directors of the Company with effect from 29 April 2021. Mr Mak Lye Mun is also appointed as Chairman of the Board.

The Board (“**New Board**”) will now comprise five directors of whom a majority are independent Directors as follows :

With the two new board members appointed, the New Board has also taken a review of its composition and the Board Committees taking into account the current Board size.

As part of streamlining the Board processes and to facilitate decision making, the Board will undertake assessment of all merger and acquisition opportunities and investment activities from the Investment Committee. The Investment Committee will therefore be dissolved accordingly.

At the same time, the New Board will also assume as Audit Committee members with Dr Tan Boon Wan continuing as Audit Committee Chairman.

In addition, there will also be some changes to the composition of the Nominating Committee and Remuneration Committee.
