Intraco Limited (the "Company") announced on 22 June 2023 that the Company has launched a S\$50 million multicurrency, unsecured and unsubordinated commercial paper facility programme (the "SDAX CP Facility Programme") on a recognised licenced digital platform in Singapore operated by SDAX Exchange Pte. Ltd.

In connection with the above, the IL_D009_1/SGD, which was launched on 20 August 2024, under the SDAX CP Facility Programme, had matured on 19 September 2024.

Accordingly, the 50 Tokens under the IL_D009_1/SGD (with an aggregate principal amount of S\$500,000) that were issued to Mr Mak Lye Mun have been fully redeemed by the Company on 19 September 2024.

The IL_D010_1/SGD Issue was issued at an interest rate of 4.00% per annum, and matures on 22 October 2024 from the issuance of IL_D010_1/SGD Tokens that are issued by the Company and listed on the SDAX Platform to accredited investors and institutional investors.

Mr Mak Lye Mun has subscribed for 50 Tokens with an aggregate principal amount of S\$500,000 under the IL_D010_1/SGD Issue.

The IL_D010_1/SGD Issue had closed on 19 September 2024 and Mr Mak Lye Mun was issued 50 Tokens in respect of the IL_D010_1/SGD Issue on 19 September 2024.
